

### 18. Journal Subscription Manager for Joe Bloggs

SSRN Networks include Free and Fee-based journals.

Network access is required to subscribe to Fee-based journals. Individuals can BUY network access for an annual fee that varies across networks, JOIN an organizational site subscription, or REQUEST one-time limited period trial access. Once you have obtained access to a network you can subscribe to both Free and Fee-based journals in that network.

SSRN members may subscribe to institutionally sponsored Free journals without network access.

22. The next step is to upload your Journal papers, and or Conference papers as work in progress should you wish. The papers you upload are your personal choice, particularly the case with unpublished articles. However, as a general rule of thumb you can
- a. Upload Full articles for which you still own the copyright (this may be helpful if you have published an article in a journal that is not available in the electronic form)
  - b. Upload Abstracts and DOI's to articles that you have signed away your copyright.
